Discussion

Chairman N. Sanchez asked if there were any questions. Commissioner Chris Mazauskas questioned Polcari & Co. bill of \$4,075. The concern is that Accountant, Tony Polcari should be phasing out in assisting Deborah Hurley, Executive Director with the onboarding process. Chairman Carlos N. Sanchez explained that the board had approved for Tony Polcari to serve as Acting Executive Director as well as, Accountant and that is why there are two bills. As we approach the end of the year, it was assured that Tony's role in assisting the executive director with the onboarding process would be completed. Deborah Hurley, Executive Director has been working closely with Tony in acquiring necessary documents and ascertaining the policies and procedures to run the housing authority. Deborah Hurley, Executive Director explained that Tony Polcari, Accountant still assists with providing information that is essential to working with H.U.D. Chairman N. Sanchez expanded by mentioning the H.U.D. process in making the transition when the former executive director resigned was a process that took time, he personally was engaged to ensure controls were in place for the housing authority. Deborah Hurley, Executive Director expressed the next phase of Tony Polcari, Accountant assistance will be working with her to explain the budget and accounts and assured Commissioner Mazauskas that training on the budget would take place. Chairman N. Sanchez stressed to the full board that he does not want the Executive Director to be accountable for the accounting for the housing authority. The accountant that is designated will be responsible with all services related to accounting. The Executive Director should have knowledge of the budget only. Commissioner Walter Szoludko posed a question about fiduciary responsibility by the board, attorney, and accountant. It was assured by Chairman N. Sanchez that all parties mentioned have fiduciary responsibility to the housing authority. Chairman Sanchez asked if there were any further questions about Tony Polcari's bill. There were none. Chairman Sanchez asked about the reimbursement expense of \$63.05 to Deborah Hurley, Executive Director for hotel reservations made for Gladyis Gonzalez. Executive Director, Deborah Hurley explained that her credit card was used to reserve a room, since Ms. Gonzalez needed to be removed from her home because of the toxic fumes that were used in the unit next door to exterminate flees. Ms. Gonzalez is a cancer patient and her doctor had advised her to leave her residence for 24 hours. Since she had no place to stay, the Edison Housing Authority made accommodations for the family. In addition, Deborah Hurley, Executive Director explained that efforts were made to find the lowest rate for the room.

Deborah Hurley, Executive Director also assured everyone that time was spent with the Labor Attorney, Richard Shaklee to ensure that the personnel manual coincided with the employee union contract. Commissioner Mazauskas inquired about the ability to receive a copy of the manual, as it is required that all commissioners should have access and copies of all policies and procedures. It was assured by Terrance Corriston, Attorney and Deborah Hurley, Executive Director that once approved, copies of all policies would be provided to the commissioners. In addition, the policies will be made available on the website, once the redesign of the website has been completed.

a.) Chairman N. Sanchez asked Deborah Hurley, Executive Director to provide an update on
