#### Section 8 Program

Zena Sutton, Director of Section 8 reported the following:

- Section 8 program is financially on target with 341 families housed.
- Graduation of an FSS participant who purchased a home and approved continued management of escrow accounts.
- We achieved High Performer status under HUD guidelines this year.

Executive Deborah Hurley, recognized staff for their effective communication and follow-up with families; potential program staffing expansion was mentioned as a need to be expanded on in 2026. year.

#### Executive Director Report:

- Edison Housing Authority and Highland Park Authority property achieved HUD High Performer status.
- Resident Commissioner for HPHA was appointed.
- Public Housing Maintenance issues at EHA included: Summer sewage problems and remain an issue at both properties, payment agreements and court actions remain in progress for residents at both properties.
- Capital improvements and security projects underway, including camera installation at Robert Holmes property.

#### **New Business:**

Executive Director, Deborah Hurley mentioned that there are several community initiatives that have taken place and are on the horizon for the end of 2025:

- Back-to-school program was a success serving more than served 200+ families and included haircuts for boys;
- STEM Program will begin in mid September and the Girl Scouts program is being supported by a grant this year.
- RAD Community meetings is scheduled for September 24th

Commissioner Toni Johnson inquired about the concerning incident with a resident living at Julius Engel Gardens. Deborah Hurley, Executive Director provided insight about the meeting with the family to assist with deescalating the concerns and suggested additional measures be implemented by the family to ensure that everyone is safe.





EHA's LRPH/COCC fiscal YTD net operating profit through September 30, 2025 (3 months of the fiscal year) is \$9,809.

Operating Revenues – YTD operating revenues are \$581,082, or \$31,695 (5.8%) better than budget.

- o Tenant rental revenue is \$228,325 or \$3,325 (1.5%) better than budget. The Authority must make every effort to collect rents as the tenant accounts receivable balance is currently above \$195,000. The Authority should also begin to evict tenants who are several months behind on paying their rent. The tenant accounts receivable detail report should be reviewed by the Executive Director and Housing Managers each month to determine the tenant balances that can be collected and the balances that should be written off as uncollectible. AMP 1 occupancy rate is 76% and AMP 2 is 97%.
- o Operating subsidy is \$237,475, or \$19,475 (8.9%) above budget, due to HUD's allocation methodology.
- O CDBG grant revenue is \$0, or \$5,000 (100.0%) below budget. This is a state/county cost reimbursement grant, so the Authority will be reimbursed for expenses as they submit them.
- o FSS grant revenue is \$21,394 or \$7,644 (55.6%) above budget. The Authority applied for and was awarded this grant in February. The funds are used to pay salaries and benefits expenses related to tenant empowerment activities.
- Other revenue is \$93,888 or \$6,251 (7.1%) above budget. Other revenue includes management fees from the HCV program and Highland Park HA, interest and other miscellaneous revenues.

Operating Expenses – YTD operating expenses are \$571,273 or \$28,514 (5.3%) higher than budget.

- Salaries and benefits are \$230,375, or \$35,684 (13.4%) better than budget, primarily due to one employee out on disability. This employee is paid via insurance and the Authority has hired a temporary staff person as a replacement. The temporary staff expense is included in other operating expenses and not salaries.
- o Utilities expenses are \$96,935, or \$5,815 (5.7%) better than budget.
- Maintenance materials/contracts expenses are \$51,175 or \$12,825 (20.0%) above budget. The largest vendors through September were Interstate Waste \$6,000, DWC Enterprises \$8,000 and Pathogend of NJ \$6,117. Pathogend was an unbudgeted expense related to bio-decontamination of the Authority offices, bathrooms and community room.
- o RAD Consulting fees are \$89,022, or \$72,772 (+100.0%) higher than budget. The Authority paid PGIM Real Estate \$66,297 and Brooke Group \$22,725. We believe the RAD consulting fees can be paid with capital funds and will draw-down the funds if possible. If capital funds can be used, next month's summary will exclude these costs.
- Other operating expenses are \$103,766, or \$10,066 (10.7%) higher than budget. These expenses include legal, staff training/travel, accounting, telephone, miscellaneous office expenses, tenant services expenses, PILOT, IT expenses and CDBG grant related expenses.

#### Housing Choice Voucher Program

EHA's Housing Choice Voucher program's fiscal YTD net operating profit at September 30, 2025 is \$27,396. The Authority's HAP expenses are covered by funding received from HUD. The administrative funding received by the Authority is \$27,396 more than the YTD actual expenses incurred. Edison HA's HCV program has received an increase in administrative funding from HUD during the last couple months.

#### **Unrestricted Cash & Investments**

The Housing Authority and the Edison Affordable Housing Corporation continue to maintain strong cash and investment balances in each of its programs. Total unrestricted cash and investments is \$4,040,052.

#### Grant Summary

The Authority has approximately \$945,000 of unexpended capital funds available for upcoming capital improvement projects. Please note the CFP 2025 just became available for use a few weeks ago.
