REQUEST FOR PROPOSALS

The Housing Authority of Edison Housing Authority, Edison, New Jersey will accept proposals for Inspection Services for its Section 8 Voucher Program that has a total of 340 Section 8 Vouchers of which 40 vouchers are Project Based Vouchers and 65 Continuum of Carew Vouchers. All services must comply with state and local laws and be in accordance with the existing rules, orders, directives, regulations and handbooks promulgated by the United States Department of Housing and Urban Development. The services will be undertaken with funds allocated under the Section 8 Program.

The services that are requested will be as follows:

- 1) Conduct an inspection of all 340 Section 8 vouchers. Of the 340 vouchers, 40 vouchers are Project Based Voucher (PBV) vouchers. In addition, 65 Continuum of Care Vouchers.
- 2) Conduct new move-in inspections as directed by the Housing Authority;
- 3) Re-inspect all units that fail the initial HQS inspection within required time from 24 hrs. to 30 day of the initial failure;
- 4) Notify the Housing Authority of all failed units in order that the owner can take corrective measures and request a re-inspection.
- 5) Submit completed HQS inspection in PHWeb software program used by to the Housing Authority same day of the actual inspection.
- 6) Perform other inspection services as requested by the Housing Authority

Qualifications:

- 1) Must have at least three (5) years experience performing HQS inspection services at other PHAs.
- 2) Must be approvable by the United States Department of Housing and Urban Development to provide these services.
- 3) Must have NSPIRE certification.
- 4) Must be experienced in using PHWeb software program.

All persons interested in submitting a proposal for the inspection services should submit a proposal based upon a per unit price. The following items should be included in the proposal:

The contractor shall, at its own expense, appear, defend, and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the owner's grievance procedure, the contractor agrees to abide by any decision of the owner which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the owner, or if the owner incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the contractor shall satisfy and discharge the same at its own expense.

The owner shall, as soon as practicable after a claim has been made against it, give written notice thereof to the contractor along with full and complete particulars of the claim, If any action or administrative proceeding is brought against the owner or any of its agents, servants, and employees, the *owner shall* expeditiously forward or have owner or its representatives.

It is expressly agreed and understood that any approval by the owner of the services provided by the contractor pursuant to this contract will not relieve the contractor of the obligation to comply with the Act and to defend, indemnify, protect, and save harmless the owner pursuant to this paragraph.

It is further agreed and understood that the owner assumes no obligation to indemnify or save harmless the contractor, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the contractor expressly understands and agrees that the provisions of this indemnification clause shall in no way limit the contractor's obligations assumed in this Agreement, nor shall they be construed to relieve the contractor from any liability, nor preclude the owner from taking any other actions available to it under any other provisions of the Agreement or otherwise at law.
